DETAILED STATEMENT OF FACTS/CONTENTIONS OF THE GRIEVANT

Supervisors has performed bargaining unit work in absence of a clerk. The union states this is a violation of the CBA Article 1.6.A and is an on-going issue when management displaces full time regular P. Pham outside of her bid assignment. The union states this is a violation of CBA Article 37.3.F.10.

The dates supervisor's performed clerk duties includes duties normally performed by Pham Phuong of will -call, prepaid acceptance scans, sorting outgoing mail & acceptance of mail drop off, dispatch and clearing carriers of accountable items are from September 24 through 10/04/ 2021. The union charges the agency with 8 hours for each day clerk Phuong is absent to perform the PM operations.

Full time regular PHAM PHUONG holds a mail processing bid 70340681 EIN #3504979 reporting time 1015-1915-60L-SU-ROT, performing duties of WILL-CALL, DISTRIBUTION OF STANDARD AND ALL OTHER CLASSES OF MAIL. PM CAGE, DISPATCH, PRS AND UBBM, MTE EQUIPMENT. SAT SCHEDULE 0830 AT MAGNOLIA PROLONGED STANDING. The agency has displaced her to perform prior sales service associate skills at the Magnolia finance.

This station has been subject to supervisors performing bargaining unit work as an ongoing issue grieved in 2021 under local number CS-143-21, CS-163-21, CS-182-21, CS-247-21, CS-256-21, CS-281-201 and CS-304-21. Specifically CS-143-21 was understood that management is required to schedule a clerk to perform PM operations.

This unit has bid reversions and has failed to maintain the efficiency of the operation. The union states that management has violated CBA Article 3. C. to maintain the efficiency of the operations entrusted to it; D. to determine the methods, means, and personnel by which such operations are to be conducted. The agency continues to fail to cooperate in good faith and resolve this issue at the lowest level with efforts to resolve this continued issue as described in the CBA Article 15.
